Dear Parents/Guardians,

This letter includes important information about the fees and inclusions for the SRS. If you have previously opted in to the IM SRS by completing the online form via QParents your participation is assumed for the remainder of your child's enrolment in the Instrumental Music Program, unless you inform the school otherwise. If you are a new parent to the school, this information will assist you in making a decision as to whether you wish to participate in the SRS.

Each year a new Consent will be created in QParents, Parents are invited to submit a response each year however for continuing students, the school is able to complete this manually from data received the previous year if new consent is not completed by the end of week 1 of the school year.

What is provided Queensland Government?

The Queensland Government supports children's education by providing funding for instruction (teachers), facilities (school grounds and buildings, internet), and administration (staff to run the school). Funding for schools does not extend to individual student resources such as textbooks, equipment for personal use, and many items used by the student in the classroom.

The SRS helps parents to source these resources. The school can purchase resources at lower rates due to its bulk buying power. Resources such as textbooks or musical instruments that will be used over a period of time are hired to students to further reduce costs for families. Participating in the SRS also offers a convenient way for parents to source the items that their child needs for school, and ensures that all students have access to the same standard of resources.

The types of resources that will be included are:

- → Owned by the student e.g. student diary once provided, these items are retained by the student and used at their discretion.
- → Hired to the student for a specific duration of time e.g. textbooks or musical instruments -these items will need to be returned to the school in reasonable condition at the end of the hire period or if the student leaves the school.
- → Used in class e.g. stationery, material, workbooks these items will be used in class. Finished products that are created from these resources will generally come home with the student.

The Fee

The SRS - Instrumental Music fee is calculated per individual student and does not include any instrument hire fees.

The school owns a limited number of instruments which will be hired to selected applicants - usually for one year only. After this time, you will be asked to supply an instrument if you wish for your child to continue their tuition. Students who learn larger very expensive instruments such as double bass, bass clarinet, French horn, euphonium and tuba will have the option to hire these from the school for the duration of their tuition after payment of required fee.

Other incidental expenses such as music tuition books, instrument reeds, music stands, excursions/workshop etc are also an ongoing responsibility of the parent/guardian to provide for their student as needed. Emergency supplies are available as per the resource list.

If you are not satisfied that the SRS fee represents good value for money based on the inclusions (over the page), you may choose not to participate in the SRS. If that is the case, please complete a new Participation Agreement Form, indicating that you no longer wish to participate. If you choose not to participate, you will be provided with a detailed list of resources that you will need to provide for the student.

Please be aware that there may be two lines of charges on your invoice indicating the GST inclusive and GST exclusive fees depending on the resources supplied by the SRS .

Cost

Cost of the SRS \$60.00

If you have opted to pay the SRS by term instalments you will receive an invoice for the full amount and term instalments of \$20.00 will be due end of week 3 in Term 1, 2 and 3.

Financial Difficulty

If you would like to participate, but are experiencing financial difficulties, please contact the school to arrange an appointment to discuss options. Any information that you provide will be confidential.

Release of resources

Resources will not be distributed until receipt of your participation agreement form (or online Qparents consent completed) or the full or first payment has been paid to the school. Any unpaid invoices, will be managed according to the department's Debt Management Procedure and may result in the student being excluded from the scheme and/or from participating in extra-curricular activities until payments are made.

Return of hired resources

A repair or replacement cost will be charged to the parent for any items that are damaged or not returned.
